

## Politika varnosti proizvoda

V okviru široke ponudbe proizvodov in storitev, Kolektor kupcem ponuja tudi takšne, ki vplivajo na varnost in zdravje ljudi oziroma je od njih lahko odvisno njihovo življenje. Za vse tovrstne proizvode in storitve je naša prioriteta odgovornost doseganja zahtev kakovosti ter zaveza k varnosti proizvodov.

Naš pristop k varnosti proizvodov temelji na sledečih načelih.

- Splošna načela: *prepoznavanje in izpolnjevanje zahtev za varnost proizvodov, načrtovanje in razvoj sistema, procesov in postopkov dela za zagotavljanje varnih proizvodov, usmerjenost v produktni management, prepoznavanje rizikov ter hitro reševanje problemov, večati zavedanje za varnost proizvoda, stalno usposabljanje in motiviranje zaposlenih, redno pregledovanje, nadziranje ter izboljševanje sistem varnosti proizvoda, spodbujanje kulture varnosti proizvodov po celotni organizaciji.*
- Varnostni vidiki v okviru zasnove in razvoja: *pozorna obravnava zahtev za varnost proizvoda, identifikacija in ocena varnostnih tveganj, usmerjenost k robustnosti konstrukcije izdelka, osredotočenost na zanesljivost, načrtovanje ukrepov za hitro in učinkovito zmanjšanje/odpravo tveganja.*
- Varnost v okviru nabave in proizvodnje: *uvajanje, presojanje in spremljanje ukrepov varnosti proizvoda pri dobaviteljih, s poudarkom na proizvodnji, validacija projektov, prototipiranju izdelkov, nabavi materiala in orodja, nadzoru proizvodnih specifikacij in ostalih relevantnih dokumentov ter testiranju vzorcev.*
- Varnost na trgu: *zagotavljanje, da izdelki dani na trg še naprej izpolnjujejo vse varnostne zahteve. To dosegamo z jasno določenimi odgovornostmi prevoznikov in ostalih v dobavni verigi ter s spremljanjem informacij in zbiranjem podatkov. Ti nam služijo za analizo vzrokov ter izvedbo ukrepov v primeru, da nevarnosti niso bile prepoznane tekom zasnove ali proizvodnje.*

## Product Safety Policy

As part of a wide range of products and services, Kolektor provides its customers also with such products and services that could affect their safety and health or even their life. For all such products and services, our primary responsibility is to meet the quality requirements and the commitment to product safety.

Our approach to product safety is based on the following principles:

- General principles: *identify and fulfill product safety requirements, planning and developing a system, processes and work procedures to ensure safe products, product management approach, identifying risks and solving problems quickly, raising awareness of product safety, continuous training and motivating employees, regularly reviewing, monitoring and improving the product safety system, promoting a product safety culture through the whole organization.*
- Safety aspects of design and development: *Careful consideration of product safety requirements, identification and assessment of safety risks, focus on robustness of product design, focus on reliability, planning measures to quickly and effectively reduce / eliminate risk.*
- Safety in purchasing and production: *introduction, assessment and monitoring of product safety measures at suppliers, with emphasis on production, project validation, product prototyping, procurement of materials and tools, control of production specifications and other relevant documents, and samples testing.*
- Safety in the marketplace: *ensuring that products placed on the market continue to meet all safety requirements. This is achieved through clearly defined responsibilities of carriers and others in the supply chain, as well as by information monitoring and data collection used to analyze the causes and implement measures in the event that hazards have not been identified during design or production.*
